Project: Nursery school renovation

Objective:

To renovate and equip eight nursery schools, benefitting approximately 1,500 children up to the age of six in Shaanxi province

Target: £65,880



Why Plan works in China

Poverty in China is widespread especially in rural areas, with almost 500 million people living on less than £1 a day. In China, less than 5% of children under three have access to a nursery school and less than 35% of children in rural China have had any education before enrolment in primary school.

Plan recognises that education is a crucial way to beat poverty – enabling boys and especially girls to gain the skills and knowledge they need to pull their communities out of poverty and reach their full potential in life.

How you can help

We aim to raise £65,880 to renovate and equip eight nursery schools in Shaanxi province. These schools will give children up to the age of six the mental and physical stimulation they need to start learning before they attend a formal school. Plan will also give parents the training and support they need to promote and assist their children's education.

Children that have had interaction at an early age are much more confident, have better concentration levels and the ability to learn new skills more quickly than children who have not had any education before attending primary school. This project will give children the opportunity to achieve higher academic standards in later life and a better chance of working their way out of poverty.

Plan enables poor communities to take action together to achieve children's rights to an education, decent healthcare, clean drinking water and more. We give long-term practical support so poor communities can improve the lives of their children and themselves. We also campaign to change the way a whole range of adults - from parents to politicians - think and act, because we know their decisions can perpetuate poverty.

Children themselves can be powerful advocates for change, so we encourage them to take part in decision making, from village councils to national assemblies. And because children will be the leaders of tomorrow, we believe that strengthening their voices now will create a fairer, better world - now and in the future.

This is just one of many projects within Plan's wider education programme. With your support, this project can make a difference to the lives of many children, families and communities in China.
