

# Vital project in Tanzania



**Project:** Nursery school equipment

**Objective:**

To provide 56 sets of nursery school equipment to all Plan programme areas

One set costs approximately **£175**

**Target:** **£9,850**



## Why Plan works in Tanzania

Tanzania is one of the poorest countries in the world, with 88% of the population living on less than £1 a day. Nearly half of all children do not attend primary school and schools lack the basic materials they need to engage and stimulate children in the classroom.

Plan recognises that education is a crucial way to beat poverty – enabling boys and especially girls to gain the skills and knowledge they need to pull their communities out of poverty and reach their full potential in life.

## How you can help

We aim to raise £9,850 for 56 sets of nursery school equipment in Tanzania. This will help to pay for valuable items such as pens, pencils, art materials, games and toys for children to learn through touch and texture. Enabling teachers to create more engaging lessons and provide the stimulation children need to improve their education.

Children that have had interaction at an early age are much more confident, have better concentration levels and the ability to learn new skills more quickly than children who have not had any education before attending primary school. This project will give children the opportunity to achieve higher academic standards in later life and a better chance of working their way out of poverty.

Plan enables poor communities to take action together to achieve children's rights to an education, decent healthcare, clean drinking water and more. We give long-term practical support so poor communities can improve the lives of their children and themselves. We also campaign to change the way a whole range of adults - from parents to politicians - think and act, because we know their decisions can perpetuate poverty.

Children themselves can be powerful advocates for change, so we encourage them to take part in decision making, from village councils to national assemblies. And because children will be the leaders of tomorrow, we believe that strengthening their voices now will create a fairer, better world - now and in the future.

This is just one of many projects within Plan's wider education programme. With your support, this project can make a difference to the lives of many children, families and communities in Tanzania.
