

# Vital project in Zambia



**Project:** Training for nursery school volunteers

**Objective:**  
To train 80 nursery school volunteers in Mazabuka, Chadiza, Chibombo and Mansa

**Target:** £25,100



## Why Plan works in Zambia

Zambia is one of the poorest countries in the world. Over half of the population lives on £1 a day or less. A third of children do not attend primary school and there are severe teacher shortages, with many students leaving school without having gained the basic skills in language and maths.

Plan recognises that education is a crucial way to beat poverty – enabling boys and especially girls to gain the skills and knowledge they need to pull their communities out of poverty and reach their potential in life.

## How you can help

We aim to raise £25,100 to train 80 nursery school volunteer teachers. Approximately £300 will pay for the training of one volunteer who will help to give children the attention, motivation and stimulation they need to start learning before they go to primary school. Children that have had interaction at an early age are much more confident, have better concentration levels and the ability to learn new skills more quickly than children who have not had any education before attending primary school. This project will give children the opportunity to achieve higher academic standards in later life and a better chance of working their way out of poverty.

Plan staff will also help parents and communities to set up committees in order to select new nursery school volunteer teachers. These committees will also be responsible for monitoring the volunteers and the development of the children to make sure they get the best possible education.

Plan enables poor communities to take action together to achieve children's rights to an education, decent healthcare, clean drinking water and more. We give long-term practical support so poor communities can improve the lives of their children and themselves. We also campaign to change the way a whole range of adults - from parents to politicians - think and act, because we know their decisions can perpetuate poverty.

Children themselves can be powerful advocates for change, so we encourage them to take part in decision making, from village councils to national assemblies. And because children will be the leaders of tomorrow, we believe that strengthening their voices now will create a fairer, better world - now and in the future.

This is just one of many projects within Plan's wider education programme. With your support, this project can make a difference to the lives of many children, families and communities in Zambia.
